Qualitative analysis of Criterion 1

Government Lal Chakradhar Shah College (LCS College) is affiliated to Hemchand Yadav University, Durg. The College offers Eleven UG and PG programs across Arts, Science and Commerce streams. Teaching and learning is according to the syllabus prescribed by the Affiliating University and guidelines of the Department of Higher Education. Effective Curriculum delivery is ensured by preparation of Time table, Teaching Plan and continuous assessment of syllabus completion through teaching diary and attendance registers.

Academic activities are conducted according to the Academic Calendar of the affiliating university and The Department of Higher Education. In addition to this IQAC of the College prepares College Academic Calendar and teaching departments prepare Departmental Academic Calendars for smooth conduct of curricular and extra-curricular activities. Teachers of the College regularly participate as a member of academic council, Board of Studies, Setting of the question paper and Evaluation of University exams.

The College integrates Cross Cutting issues relevant to Professional Ethics, Gender Sensitization, Human Values and Environmental Sustainability into the Curriculum. In addition to the Class room teaching, students are encouraged to participate in experiential learning through project work, field visits and educational tours. The College has a well-documented stake holder Feedback system from Students, Parents, Teachers, Alumni and teaching & non teaching Employees for continuous assessment and improvement of Teaching plans to be more specific and scrupulously followed.

Qualitative analysis of Criterion 2

Total strength of the college is 1561 and Admission process of the College is transparent and according to the norms and regulation of Affiliating University and the Department of Higher Education. The College strictly adheres to reservation guidelines of the State government in the process of admission.

In order to cater to the learner diversity, learner levels are assessed based on Previous Class performance (Entry level), Internal assessment and class room performance. Accordingly, Slow learners are given special coaching through remedial classes, notes in easy language and previous years question papers (to make them understand the university exam pattern). Advanced learners are encouraged to participate in extra-curricular activities. Meritorious students are awarded Gold medals.

Student centric methods and participative learning through project works, power point presentations, educational field visits are organized for enhancing learner experience. Teachers use ICT tools for effective teaching learning.

The college has continuous internal evaluation process including internal exams, half yearly exams and unit tests which help in the improvement of student performance. For effective teaching learning process Program and Course Outcomes are framed and communicated. Result analysis is done to evaluate the attainment of Program and Course Outcomes.

Two Faculty have abtained Ph.D. Degree and one is pursuing Ph.D. There have been 3 workshops conducted on Research Methodology and Intellectual Property Right. 15 Research Papers and books / Chapter in book have been published. There have been 7 collaborations and 1 functioning MoU. One faculty having Post Doctoral.

Faculty members regularly participate in Seminars/Conference and publish research papers. Extension activities are an important component of College function. The students are encouraged to join NSS & NCC and participate in extension activities like Tree Plantation and Cleanliness drives, Blood Donation Camps, Village adaptation and spread awareness about AIDS prevention, Eye donation, Woman Empowerment, Voter awareness etc.

Faculty members participate in joint research activities as reflected in joint publications and as research guideship. Although the College was paired with 3 Colleges of Gujarat under the Ek Bharat Shrestha Bharat Scheme, Student and Faculty exchange could not happen due to lack of funds and Covid-19 pandemic.

The college has received RUSA Infrastructure Development Grant and has good infrastructure and Physical facilities. The College has its own Campus and playground spread in an area of 9.5 Acres. The IT Infrastructure is also sound with 12 ICT enabled classrooms, 50 Computers and with wi-fi facility . There is also facility for indoor/ outdoor games. The Library is automated with KOHA -ILMS software. College Library has more than 62000 books, N-LIST subscription. departmental library facilities are made available in the college.

The College has a multi purpose Auditorium for seminars and cultural activities, moreover Sports facilities viz Football and Cricket Ground, Cricket Net Practice pitch, Volley ball, Basketball, Badminton courts, canteen, Gymnasium and indoor sports facility are also availab. As part of the Learning resources, college has a Botanical Garden, Home Science Garden, Aquarium and Fish Tank.

Qualitative analysis of Criterion 5

The College serves educational needs of students from rural, semi-urban areas in and around the Scheduled area of Ambagarh Chowki. Most of the students are from poor background and supported financially from government scholarship schemes like Post Matric Scholarship (PMS), Below Poverty Line (BPL) and National Merit-Cum-Means Scholarship.

A number of Capacity building programs for soft skill development and career guidance like Seminars, Guest lectures and Workshops are organized for the benefit of students. The College has a robust mechanism for dealing with Student grievances including Women harassment and Ragging. Most of the students from Undergraduate level opt for pursuing Postgraduate courses in the college and other nearby colleges. In addition to this, many of students have been placed as School Teachers, College Faculty, Police, Paramilitary forces, Army and Air force. The College facilitates student participation in various administrative and cocurricular activities through student union and Postgraduate Councils. There is a register Alumni Association.

Qualitative analysis of Criterion 6

The college has a carefully framed vision and mission. The leadership is visible through the different committees. The College governance is reflective of the stated Vision Mission and College leadership follows a decentralized and inclusive management through various committees and councils.

College administration has effectively implemented strategic perspective plans in the areas of Teaching Learning, Upgradation of Infrastructure Facilities, Community Engagement and Upgradation of existing Academic Profile. College policies, administrative setup, appointment, service rules and procedures are according to the State government rules and regulations.

Financial audit is carried by the Government through e-kosh but College has its own internal audit committee and JBS funds are audited by Chartered Accountant. Qualitative analysis of Criterion 7

The college undertakes a number of initiatives to promote Gender Sensitization. 33% seats are reserved for female students. Facilities like Girls common room, Girls toilet, Sanitary pad vending machine, fee concession , maternity leave and a number of Gender sensitization programs like International Women Day, Mother's

Day, AIDS awareness day are organized. Solid waste management, Rain water harvesting, Water recycling, Green landscaping have been undertaken. Energy and Environment audit has been conducted and a number of beyond campus environment promotion activities have been carried out. The college has differentially abled friendly environment with Ramp and Rail facility, Divyangjan friendly washrooms and Scribe facility for students. The college follows a policy towards providing inclusive cultural, linguistic, communal Socio-economic environment as reflected in

1. Organization of various events to promote an inclusive environment and promote

tolerance and harmony.

2. Zero tolerance for Ragging and any other form of harassment to students.

3. NSS & NCC Units are actively involved in programs to promote social and cultural harmony.

Various programs are organized by the college to promote awareness Activies like Constitution Day, Human Rights Day, Voter Awareness, Surgical Strike Day to sensitize students and staff to promot constitutional values, duties and responsibilities.

Faculty members especially from Department of English and Political Science are actively involved in academic activities like publications, conferences on the theme of Social justice and upliftment.Stu dent and Staff code of conduct is prescribed and displayed in campus and college website. The college has successfully implemented a number of best practices viz,

1. Promotion of Health and Well being through a number of awareness programs like Blood donation camps, Sickle Cell Anaemia awareness and testing camp,COVID-19 Awareness and Vaccination Camp.

2. To provide Community Service by providing college infrastructure and facilities for Local Fair (Madai Mela), Bhagvat Gita Gyan Yagya Saptah, Christian Community function. These programs not only fulfil social responsibility but also promote communal harmony and act as catalyst for inculcating moral and social values among students and staff. The college is one of the oldest higher education institute and has served educational demand of rural and tribal students. A number of State government initiatives like Post matric Scholarships (PMS), Below Poverty Line (BPL) and National Merit cum Means scholarships, Book bank and stationery distribution for ST/SC students. The College is striving for promoting Academic excellence by way of awarding Gold medals to merit holders across all disciplines.

The College has spacious campus and infrastructure facilities including Class rooms,

Laboratories, Play ground, Library and Seminar hall. The College campus has Wifi facility for students and staff. The College Faculty is experienced and highly qualified. Academic performance of College students has been consistently good. College having very good facilities for Sports and Other activities. Students of the College are supported by government Scholarships Like PMS, BPL, and National Merit-cum-Means scholarship. A number of Lectures, Seminars, Career orientation activities are carried for benefit of

A number of Lectures, Seminars, Career orientation activities are carried for benefit of students.

The College has zero tolerance towards ragging and other forms of harassment and provides a safe and inclusive environment to all students.

Weaknesses:

Students from rural background are at a disadvantage due to poor schooling and lack of communication, verbal and written skills.

Most of the students from Hindi medium schools face problems due to lack of standard reference study material in Hindi, especially in Science subjects. This problem is further compounded in Postgraduate level and ultimately results in poor performance in National level exams like NET, GATE, UPSC etc.

Opportunities:

The College offers academic programs in Science, Arts and Commerce streams. In addition to Academics, students of the college are provided facilities of Sports and Cultural training.

NCC and NSS units conduct regular activities and students joining NCC, NSS get

Certificates which provide advantage in future job prospects.

The college provides wide range of growth opportunities to teachers through professional training courses; study and research leave facility and other faculty development schemes.

Female students and Schedule category students are provided reservation according to state government rules.

Merit holders are awarded Gold medals.

As compared to other colleges annual tuition fees is affordable, and students have scholarship facilities.

Challenges:

Lack of Hostel Facilities for the students is the serious challenge.

Ever increasing demand for higher education require increase in seats, new courses and subjects, this in turn puts severe strain on the existing infrastructure and College faculty.

Apart from academic work faculty members are also engaged in non academics tasks affecting the core performance.

Better training and professional development opportunities for teaching and non

teaching staff are required to cope with ever changing academic environment especially

for implementation of New Education Policy (NEP).

Lack of Research Funding. is a serious challenge for the academic progress.
